By strengthening bonds between students, integrated anti-bullying programs can help create a school culture that does not support bullying behavior.

Apart from that, an integrated anti-bullying program also requires active involvement from all stakeholders in the school, including teachers, students, parents, and school staff. Collaboration between all parties is important to create a supportive environment for all individuals in the school [11]. Teachers need to act as role models and support efforts to prevent bullying, while students need to be encouraged to report cases of bullying that occur. Parents also need to be involved in supporting their children and working together with schools to address bullying issues. With collaboration between all stakeholders, integrated anti-bullying programs can be more effective in creating a safe and inclusive environment for all students.

The application of social psychology theories in the development of anti-bullying programs can also help increase their effectiveness. For example, theories such as social cognitive theory by Arthur emphasize the importance of learning through observation and personal experience in developing social behavior [12]. By strengthening students' social and emotional skills through integrated anti-bullying programs, schools can help improve students' abilities to handle complex social situations, including cases of bullying. In addition, approaches based on motivational theories such as the autonomy theory can also be used to increase students' motivation to participate in anti-bullying programs and adopt positive behavior [14].

In the context of English language learning, the development of integrated anti-bullying programs can also help create opportunities for meaningful and authentic learning. For example, through collaborative projects that emphasize social and emotional learning, students can learn about real-world issues and develop the skills to act as agents of positive change in society. #### G. Challenges and Strategies for Implementing Anti-Bullying Concepts in ELT

One of the main challenges is the limited time and resources available to teachers. In an already dense curriculum, adding character education and anti-bullying elements is often seen as an additional burden. One strategy that can be used is to involve parents in efforts to prevent and handle bullying. Through effective communication between school and home, parents can be invited to participate in anti-bullying programs and given information about how they can support their children at home. Parental involvement is an important factor in the success of anti-bullying programs [23]. Schools can hold workshops or information sessions for parents to raise their awareness about bullying and give them tools to help their children.

In addition, providing training and support for teachers is an important step in overcoming the challenges of implementing anti-bullying concepts. Teachers need to be trained to recognize the signs of bullying, understand the social dynamics underlying the behavior, and develop skills in mediation and conflict resolution. This training should also include strategies for creating an inclusive and supportive classroom environment, where all students feel valued and accepted. Well-trained teachers are the key to creating a safe and positive learning environment [13].

In the ELT context, teachers can use various methods to teach anti-bullying concepts. One way is to use role-playing, where students can act out various situations involving bullying and try to resolve them constructively. This method not only helps students understand the impact of their behavior but also allows them to practice social and conflict-resolution skills. Role-playing is an effective tool for increasing empathy and social skills among students [8].

Group projects can also be used as a means to teach anti-bullying concepts. In this project, students can work together to produce educational materials, such as posters, videos, or presentations that campaign for the importance of anti-bullying. Through this collaboration, students learn to work together, appreciate each other's contributions, and develop good communication skills. Group projects can help build a sense of community and cooperation in the classroom, which is important for creating an inclusive environment [10].

Open and reflective class discussions about bullying issues are also an effective strategy. Teachers can facilitate discussions about real or fictional scenarios involving bullying, and ask students to consider multiple perspectives and solutions. These discussions help students develop critical thinking skills and empathy, as well as understand the consequences of their actions. Open and honest discussions are a good way to encourage students to talk about their experiences and find solutions together [30].

Lastly, technology can be utilized to promote anti-bullying awareness in English classes. Teachers can use online platforms to provide educational resources, such as articles, videos, and discussion forums about bullying. Social media can also be used to campaign anti-bullying messages and encourage students to share their stories and solutions. By using technology, teachers can reach students in a way that is interactive and relevant to their daily lives [4].

In facing the challenges of implementing anti-bullying concepts in ELT, it is important to adopt a comprehensive and integrated approach. By combining various strategies and involving the entire school community, from students to teachers to parents, schools can create a safe and supportive learning environment. Through this joint effort, it is hoped that bullying incidents can be reduced and the social and emotional well-being of all students improved.

#### **IV.CONCLUSION**

Character education is proven to play an essential role in efforts to overcome bullying in the context of

English language teaching (ELT). Through the application of moral values such as empathy, honesty, respect, and responsibility, students not only learn languages more effectively but also develop social skills that are important for everyday life. Character education helps create a safe and supportive learning environment, where students feel valued and recognized. This positive environment increases students' self-confidence and encourages their active participation in teaching and learning activities.

Integrating character education in ELT has a significant impact on classroom climate and student well-being. Teachers who apply the principles of character education can guide students to understand and internalize positive values, which in turn reduces bullying incidents. With this approach, students learn to respect differences, work together harmoniously, and constructively handle conflict. Character education also prepares students to face various social challenges outside the school environment, making them more emotionally and socially prepared.

However, the success of integrating character education in ELT cannot be separated from adequate support for teachers. Teachers need continuous professional training and development to enrich their skills and knowledge in managing classrooms that are inclusive and free from bullying. ELT teachers are advised to actively integrate character education principles into their teaching. One effective way is to use various interactive methods such as role plays, group projects, and class discussions that discuss issues related to bullying and character values. Teachers can also utilize relevant literature and technology to enrich learning materials as well as to conduct anti-bullying awareness campaigns. By teaching students to understand and apply values such as empathy, honesty, and respect, teachers can create a more inclusive and supportive classroom environment.

In addition, schools and policymakers need to provide adequate support to teachers in the form of training and professional development. Training programs that focus on conflict management, communication skills, and anti-bullying strategies can help teachers feel more prepared and competent in dealing with bullying. Support from the school and community is also needed to ensure that teachers have the resources necessary to create a positive and safe learning environment. Collaboration with parents is also very important to ensure that anti-bullying efforts are not only carried out at school but are also supported at home. With a holistic and sustainable approach, it is hoped that bullying incidents can be minimized and student welfare can be improved.


