SYARAT PENGGUNAAN

SYARAT PENGGUNAAN DI BAWAH INI HARUS DIBACA SEBELUM MENGGUNAKAN SITUS WEB INI. PENGGUNAAN SITUS WEB INI MENUNJUKKAN PENERIMAAN DAN KEPATUHAN TERHADAP SYARAT DAN KETENTUAN INI.

Selamat datang di TIX EVENTS yang dimiliki dan dikelola oleh PT Nusantara Elang Sejahtera, sebuah perusahaan yang didirikan dan tunduk pada hukum Republik Indonesia (selanjutnya disebut sebagai "TIX EVENTS" atau "Situs Web" secara bergantian). Syarat dan ketentuan berikut (Syarat Penggunaan) berlaku untuk mengakses, menginstal, dan/atau menggunakan Situs Web. Referensi ke Situs Web dianggap mencakup turunannya, termasuk tetapi tidak terbatas pada Situs Web seluler dan Situs Web. A. LINGKUP LAYANAN

layanan dan produk yang ditawarkan melalui situs web. Penggunaan Situs Web ini merupakan persetujuan Anda untuk mematuhi versi terbaru dari syarat dan ketentuan ini ("Ketentuan"). Kami akan memberikan konfirmasi pemesanan atau pembelian melalui email kepada Pengguna yang terdaftar di Situs Web. Kami berhak untuk menolak reservasi sebagaimana dijelaskan di bawah ini.

2. Meskipun kami akan menggunakan keahlian kami dengan hati-hati dalam melaksanakan Layanan, kami tidak memverifikasi, dan tidak menjamin, bahwa semua informasi yang diberikan akurat, lengkap, benar, atau tersedia saat ini, dan kami tidak bertanggung jawab atas kesalahan apa pun (termasuk kesalahan penempatan dan pengetikan), gangguan (sementara dan/atau sebagian, kerusakan, perbaikan atau peningkatan pada Situs Web atau lainnya), informasi yang tidak akurat, menyesatkan atau salah, atau informasi yang belum terselesaikan.
